Presentation: Advisory Committee Management Office (ACMO)

• Reviewed advisory committee resources and thanked the Committee for its work on behalf of the Secretary regarding rural Veterans' access to care

Welcome, Introductions and Meeting Overview

Dale Gibbs, Chair, Veterans Rural Health Advisory Committee

• Convened the meeting, reviewed the meeting objectives, and stressed that the Committee serves the Secretary through the focus on national issues that impact rural Veterans' access to care

Presentation: VA Midwest Health Care Network (VISN 23)

Robert McDivitt, Network Director, VA Midwest Health Care Network

- Reviewed the footprint of the Veterans Integrated Service Network (VISN) 23 throughout Illinois, Iowa, Minnesota, Nebraska, North Dakota, and South Dakota
- Explained the VISN 23 focus is to move care to where Veterans are located and some of those efforts are funded by the VA Office of Rural Health
- Provided major challenges including recruitment of primary care providers, licensed nurse practitioners, and surgeons; access to mental health care in rural areas; and limited connectivity to some Community Based Outpatient Clinics (CBOC)
- Discussed associated solutions the VISN implemented such as a VISN-wide planning summit, clinician recruitment, Suicide Prevention Outreach and Education Specialists, and CBOC bandwidth upgrades
- Answered questions on geographical reach of the VISN Licensed Practical Nurse shortage; the role of nurse practitioners; employee demographics; Suicide Prevention Outreach and Education Specialists; Question, Persuade, Refer training for suicide prevention; and enrollment at rural CBOCs

Presentation: Iowa City VA Health Care System

Judith Johnson-Mekota, Director, Iowa City VA Health Care System

- Reviewed catchment area for the Iowa City VA Health Care System, sites of care, demographics of enrolled rural Veterans, and budget
- Provided information on key local initiatives that included community partnerships, telehealth expansion, and construction
- Shared major challenges such as engaging new enrollees in health care and services, cellular coverage in rural areas, and Maintaining Internal Systems and Strengthening Integrated Outside Networks (MISSION) Act, and suggested associated solutions such as a myth buster campaign, in-person/tele-town hall meetings, and VA / VA medical center contact wallet cards



 Answered questions about brain injury research, service enrollment, providers for un-enrolled Veterans, minority Veteran populations, and helping non-VA providers understand the MISSION Act

Presentation: Office of Rural Health (ORH) Update

Thomas Klobucar, Executive Director, ORH

- Provided enrolled rural Veteran demographics and comparative data against enrolled urban Veterans; highlighted that rural Veterans are more reliant on VA health care
- Reviewed ORH's legislative mandate (38 USC § 7308) to research, innovate, and disseminate health care solutions that increase rural Veterans' access to care
- Discussed the role of ORH's Veterans Rural Health Resource Centers which resulted in 356 studies and innovations; 26 dissemination of innovations; and 617 manuscripts, briefs, and reports
- Explained fiscal year 2020 funding, with a multimillion-dollar allocation for implementation of clinical resource hubs to deliver primary and mental health care via telehealth, as well as providing surge support for in-person care
- Gave update on two pilot programs: Veteran Service Organization Wellness Centers and VA Farming and Recovery Mental Health Services (FARMS)
- Answered questions on status of previous recommendations and VA FARMS

Presentation: Rural Scholars Fellowship

Michael Ohl, Rural Scholars Fellowship Director, Iowa City VA Health Care System; Sherry Brewer, Rural Scholars Fellow; and Jaime Wilson, Rural Scholars Fellow

- Explained the Fellowship provides professional growth to VA providers (medical doctor, Advanced Practice Registered Nurse, or Physician Assistant) in rural communities through a two-year fellowship with virtual curriculum, a mentored innovation project, and networking
- The curriculum focuses on quality improvement and delivery innovation; leading change methods, measurement, and analysis; eHealth; rural health policy; professional networking; and Leadership Effectiveness Accountability and Development program participation
- Explained an outcome of this Fellowship will be a ground-level, rural-focused network that can provide a "bottom up" improvement model to integrate with top-down VISN leadership for a cohort of innovators
- Mentioned the Fellowship's challenges (e.g., clinical coverage, leadership approval, mentorship), solutions, and proposed evaluation metrics
- Answered questions about program incentives, grassroots implementation models, marketing, and incentives for keeping fellows in the rural community



Presentation: Medical Innovations in the Iowa City VA Health Care System

Carolyn Turvey, Clinical Director, VRHRC Iowa City, Iowa; Byron Bair, Clinical Director, VRHRC Salt Lake City, Utah; and Mathew Vincenti, Director, VRHRC White River Junction, Vermont

- Explained ORH's research agenda that focuses on workforce, rural special populations, rural disparities, care coordination, rural access to care, operational adoption, practice infrastructure, and health policy
- Reviewed key research programs: opioid use disorder, post-traumatic stress disorder coordinated care between VA and Federally Qualified Healthcare Centers (FQHC), home-based telemedicine to improve diabetes care, postpartum depressed female Veterans, Geriatric Research Education and Clinical Center consultation with CBOC providers, and community care within the MISSION Act
- Answered questions on Advanced Comprehensive Diabetes Care and community care usage by rural versus urban Veterans
