The VISN 3 Geriatric Research, Education and Clinical Center (GRECC) at the James J. Peters VA Medical Center is one of 19 VA centers of excellence in geriatrics, research, education, and clinical models of care.



The VISN 3 GRECC is offering a new and exciting one-year fellowship program in rural geriatrics beginning **July 2014**. This fellowship program is geared towards board-certified physicians who have already completed an ACGME-accredited Fellowship in Geriatrics.

### The mission of this Advanced Fellowship in Geriatrics is to:

- Prepare geriatricians to become distant consultants to rural providers.
- Educate others on the unique needs of rural older adults.
- Remove the barrier of medical practice isolation through telemedicine modalities.
- Develop competency in establishing geriatrics programs in rural areas.
- Participate in a quality improvement research project relating to rural health issues.

## Clinical Training

Fellows in this program will acquire the necessary clinical skills to provide quality care to older adults across various healthcare settings in rural areas:

- Telemedicine consultation
- Primary/Ambulatory care
- Home care
- Community Based Outpatient Clinics
- Inpatient

## Teaching Activities

Fellows will have an opportunity to participate in several faculty development workshops to improve their teaching and evaluation skills. They will also serve as mentors to the VISN 3 GRECC associated health interdisciplinary trainees.

## Research Program

Approximately 50% of this one-year fellowship will be geared towards research, evaluation, and quality improvement. Fellows will have an opportunity to work with GRECC and Mount Sinai faculty on various projects relating to rural health issues.
